

Dock Street Apartments Will Help Build Strong Sense of Community

Construction on the Dock Street Apartments began in mid-September. "It's a typical infill urban site," says Scott Clements, project manager at Frana Companies. "We've peeled off some asphalt to get under a parking lot and there are always surprises. So there was some expectation of debris, and there's always a little bit more than expected." By early November it was all worked through, and footing work and soil correction began.



Northland Concrete and Masonry located in Burnsville, Minn., and Hanson Structural Precast located in Maple Grove, Minn., will begin working onsite in December.

"It will be an interesting, neat looking building," says Clements. "The north half will be brick exterior and the south half will be a metal shingle siding."

The project is funded through a joint venture between the international real estate firm Hines and the AFL-CIO Building Investment Trust (BIT) (See page 8 for more info on the BIT).

Clements credits Hines for pulling the team together about a year ago. Frana was awarded the project in late 2011 and since has been working with Hines, ESG Architects and design, build, mechanical, and electrical contractors. "There's been a tremendous amount of planning going on," he says. "I certainly want to believe that we've worked through and resolved many of the issues that come up during construction." Barring the unearthed surprises found in a typical urban infill site, he anticipates smooth sailing ahead. "It's great project at a fabulous location."

Partial occupancy is expected before the completion date of December 2013. Total cost is approximately \$40 million.

From the President

Local-wide **Wage Allocation** Meeting

Members from all chapters of BAC Local Union 1 MN/ND are invited to attend the local-wide

wage allocation meeting on Saturday, Jan. 5, 2013, at 9 a.m. The meeting will be held on the second floor of the United Labor Center, 312 Central Avenue, Minneapolis, MN 55414. Although most areas and crafts in Minnesota will have expiring contracts in 2013, it is necessary to take care of some of the allocations to common funds whether or not any increases are negotiated.



International Union Pension Fund

The trustees of the International Pension Fund (IPF) have taken steps to correct the funding deficit in that plan. Under new regulations from the federal government and under the provisions of the Pension Protection Act (PPA), the fund was required to come up with a 10-year funding improvement plan. As a result, a 15 percent PPA funding mandate was attached to the contribution rate in May 2010. At that time, a comprehensive plan was laid out by the trustees who will give local unions two choices:

Choice 1 – No increase in funding was scheduled for 2012. From 2013 through 2016 a 4 percent annual increase to contributions followed by 2017 through 2021 a 6 percent annual increase in funding is required. Most of our crafts and areas are contributing at the rate of \$1.50 plus the PPA contribution of \$.23. The 4 percent increase would mean an additional \$.07 would be contributed beginning May 1, 2013. This funding choice leaves intact the accrual rate at \$21 per credit and grants a full pension with no reductions at age 60. Ten credits are required to be eligible for this pension.

Choice 2 – No increase in funding was scheduled for 2012. From 2013 through 2021 a 3 percent annual increase to contributions is required with no increase due in 2014. The 3 percent increase would mean an additional \$.05 would be contributed beginning May 1, 2013, for areas and crafts that are currently contributing at the rate of \$1.50 plus the PPA contribution of \$.23. This funding choice reduces the accrual rate to \$12.75 per credit and increases the age for receiving a full pension with no reductions to age 64, with 6 percent reductions for each year an active participant's retirement precedes 64. Ten credits are required to be

eligible for this pension.

Please keep in mind that all service credits and early retirement reductions prior to January 2013 remain the same as when they were earned. We will be discussing and voting on this issue as a Local. Once we make our choice, the plan funding obligation will remain in place until 2021.

BAC Local Union Defined Benefit Pension Fund

The trustees of the BAC pension have also met to discuss the projected deficit in funding. Even though the performance of the fund has been good the last few years, we are still suffering from the effects of the market crash in 2008. With more BAC members retiring early, retirees and spouses living longer, and the losses in 2008, it has been increasingly difficult to balance the budget projections required by law. While the fund is in the "Green Zone" and is projected to be there for three years, projections show that we will fall into the "Yellow Zone" during the fourth year. Under the PPA we are required to take corrective action to keep the fund in the "Green Zone".

The trustees have taken three corrective measures to keep the fund in the Green Zone for the next 30 years:

- 1) Raising the full retirement age to 62. Ten credits are required to be eligible for this pension. Pension credits earned before Jan. 1, 2013, would not be affected by this change.
- 2) Early retirement reductions of 3 percent per year from 60 to 62 and a 5 percent per year reduction from 55 to 60. Keep in mind that, even with these changes, pensions before age 65 are still subsidized by the fund. A full actuarial reduction would be approximately 6 percent per year (e.g., an 18 percent reduction at age 62 or a 30 percent reduction at 60).
- 3) Lowering the accrual rate from \$175.75 to \$160.00 as of Jan. 1, 2014. This change keeps the current rate in place through 2013.

While the trustees have to make tough decisions on how to balance the budget within the plan the members have the ability to lessen the impact of these changes with additional funding. The members will be voting on funding improvements for the plan. Additional contributions will help balance the budget and protect the pension. Additional contributions not only help keep the plan stable, but give the trustees the ability to raise the accrual rate, when economic conditions permit, on a year by year basis going forward. A commitment of at least three years at \$.25 per year will be discussed. Additional funding scenarios will also be discussed at the meeting.

Health Fund

The trustees of the Health Fund were able to keep costs in check the last few years. We had no increase in the contribution rate for 2010 or 2011. We had a \$.25 increase in the contribution rate in 2012. With health care and compliance costs increasing dramatically through that same time frame, the trustees know that we have to make some changes soon. Additional contributions on May 1, 2013, are necessary for the plan to keep operating.

In addition to the increase to the Health Fund itself we have to discuss a slight increase to the prefunding contribution rate. Currently we have \$1 per hour of our Health Fund contribution going toward the prefunded subsidy for our retiree health care. I am proposing that the members allocate an additional \$.10 per hour to prefund, during our working careers, our own retiree health care. We will be voting on this as a separate item on Jan. 5, 2013.

International Masonry Institute (IMI)

Under a Resolution from the 2010 International Convention, all BAC crafts are required to contribute 1 percent of the total wage package to the IMI. Most Local 1 crafts voted to get half way to the 1 percent contribution rate in 2012. All crafts will be mandated to contribute 1 percent on May 1, 2013.

Extend Health - Medicare Supplement

Jan. 1, 2013, all of the BAC retirees and spouses on Medicare will be moving to a Medicare Supplement on the open market. Extend Health, a Medicare Supplement broker, has been helping our retirees find a supplement on the open market that fits their needs. The BAC supplement had a "One size fits all" approach to supply the Medicare supplement. It wasn't practical in today's market place. We are very pleased by the results that we are seeing as we make this transition. Many of our retirees are reporting substantial savings as they are signing up for their new supplements. We are seeing savings from \$25 for an individual and up to \$300 per couple. This is real money that our Medicare retirees will be saving on a monthly basis. And frankly, that is why we made this change, to save money for our retirees.

Wrap Up

We are undergoing many changes. To keep everything at the status quo is not an option. The BAC officers and trustees are working diligently to provide the best possible benefits under the current circumstances. With that in mind, please come to the local-wide wage allocation meeting on Jan. 5, 2013, to help make the necessary changes to keep the benefits going strong into the future.

Minnesota Negotiations

Most crafts and areas voted for negotiating committees during the Local 1 2011 nominations and elections. All positions are not filled. 



The AFL-CIO BIT and HIT and Your Pension Dollars

Roughly 50 years ago the AFL-CIO established the AFL-CIO Housing Investment Trust (HIT). In 1988, the AFL-CIO Building Investment Trust (BIT) was established. Each group is operated independently with its own portfolio management group that makes investment decisions.

"The BIT and HIT invest union pension dollars in a socially responsible way. We don't sacrifice returns," says William Little, vice president of the **AFL-CIO Investment Trust** Corporation. "Our number one priority is to get returns and protect the retirement security of the union members who are beneficiaries of the pension plans. All our investments are prudent. Our second mission is to create union jobs. We are investing in a way that represents the values of the union members. Everything we build is 100 percent union. The service and maintenance on our properties is also done by union signatory contractors, too."

The BIT is an equity fund focusing on offices, apartments, hotels, retail centers and industrial properties. In contrast, the HIT makes fixed-income investments in housing. Little covers smaller cities in his region, such as Milwaukee, St. Louis, Minneapolis and Pittsburgh. Historically the BIT has invested \$4.3 billion in more than 160 real estate transactions. In the last 18 months it has invested more than \$1.5 billion in real estate development; investing in 11 real estate deals representing \$1.3 billion in real estate development and 7.5 million union construction hours. Two investment projects in Minneapolis, the Flux apartments in Uptown and the Dock Street apartments near Target Field, represent approximately \$80 million in real estate development and are credited for nearly 500 union construction jobs with 600,000 union construction hours. recession) we've seen an opportunity to invest, to build, give good returns and to create union jobs. We've implemented that plan, and we think it's been very successful," Little says.

Paul Sommers, regional marketing director for the HIT, services 13 states in the Midwest. "The HIT is a debt player," he says. "We do construction or permanent financing for residential buildings." Its current focus is on multifamily apartments and senior citizen facilities. In the last 10 years, HIT investments have created approximately 762,000 hours of BAC work in Minnesota.

In 2009 the HIT began a jobs initiative that has created 15,000 union construction jobs in just three years. "We fulfilled that commitment so we have raised our goal to 20,000 jobs by the end of 2012," says Sommers.

The HIT has more than \$4.5 billion in assets. About 75 percent of its clients are Taft Hartley funds and labor organizations. The remainder is public funds such as teachers, firefighters and others. According to the HIT's publication Investor, the HIT recently earned a Morningstar ranking as one of the nation's "Top Performing Managers" for the one- and five-year periods ending June 30, 2012.

"Building trades have been more than 40 percent of our new business the last three years," Sommers says. "This has been a validation of our job creation success and also of our consistent, very solid performance." BKV Group, Architec

The Midwest has been a hot area for development for the HIT. Under its jobs initiative, the HIT has done 49 projects in 27 different cities, over half in the Midwest alone. Minnesota has been the location for ten of these projects and more than 1,800 union construction jobs.

Similar to Little, Sommers says the focus of the HIT is to preserve participant assets and deliver competitive returns.

RETIREE HIGHLIGHT

"Tuffy" is Running Example of Just Do It

Wayne Paschke began running several decades ago. And he's still running. He recently won the William A. Irvin 5k in Duluth, Minn., for his age group.

When returning from a Canadian fishing trip many years ago with a friend, they both saw runners running along the North Shore. His friend stated he was going to give it a try, so Paschke with his "If he can do it, so can I" attitude began training with his friend.

At that time Paschke didn't know how far a marathon was, but that didn't stop him. His first marathon was the "Torturous 26" which was part of the St. Paul Winter Carnival. He completed it, but with hypothermia. The following spring in 1981 he completed Grandma's Marathon in Duluth, Minn., and he's been running ever since.

A Minneapolis high school graduate, "Tuffy" as he is known by his friends and fellow bricklayers, came from a family of bricklayers. His father, George, was a bricklayer in Union 2 in Minneapolis, as were his brothers Kenneth, Donald, and Gerald. All have since passed away. Paschke retired in 2000 after nearly spending 45 years in the trade.

Today, a lot of his family members run. He and his wife, Sharon, have three grown children: two daughters and a son. His son and son-in-law are runners. Three of their seven grandchildren are dedicated runners, too. They all live in the surrounding communities and once in a while they'll run together.

Paschke once belonged to a running group that ran once a week practicing various techniques such as running uphill, downhill, and running barefoot in parks. They ran on tracks and ran relays. The group ran the Edmund Fitzgerald 100k, a 62-mile road race in Duluth. "We completed it four times," he says. "A few guys eventually dropped out of the group and some couldn't run any longer so we ceased." As far as training goes in recent years, he keeps it very simple; he keeps his weight down before a race. "I'm at the same weight as when I was 19. Now I just go out and do it."

He runs five miles every morning and 10 miles or farther on weekends. Paschke doesn't run in the winter because of the cold and instead uses his stationary bike



and treadmill. He also enjoys biking and watching the Olympics, especially the running, gymnastics, swimming and volleyball events. "I like it all," he says. He watches the Vikings, too, but without cable television, he has to either attend Twins games or listen on the radio.

In the fall, Paschke and another retired union friend hunt for duck, grouse, turkey, and deer. They go ice fishing, too.

To date, his accomplishments tally more than 40 marathons. His best time was 3:21. He's run upwards of 80 10K races. He's run every Medtronic Twin Cities 10 Mile. "I used to do the Twin Cities Marathon and Grandma's, but they're getting a little tougher, so now I'd rather do the half marathon and 10 mile races," he says. Competition is dwindling in

his age group so "I'm getting better by eliminating my competition through longevity," he chuckles. "There aren't a lot of guys my age running so I'm becoming a better runner. A lot of friends have a hard time walking. I don't go out for the win. I go out running and just try to maintain."

His favorite shoe is Mizuno, a shoe he discovered while watching elite runners. It's probably one of the more expensive shoes, but Paschke likes it. He's used Sacony and Nike in the past.

To the guys on the job, Paschke says, "Smoking is bad for you." He tried smoking in his younger years, and quickly learned it wasn't good. Today he doesn't drink, doesn't smoke and doesn't gamble. "I live a boring life except for running."

He recommends to those beginning an exercise plan, start out slowly and enjoy what you are doing. If you don't enjoy it you can't maintain what you are doing. "I like running because it was at my time. I didn't have any certain schedule. When I could fit it in I would usually go out and run," he says. "Now I have more time to do it."

He attributes his good health to running. "It makes me a little more health conscious and of what I'm eating," he says. "And the bricklayers have been really good to me over the years, too."



MN AFL-CIO Statement on the 2012 Elections

It is now time to begin the work of completing Minnesota's economic recovery and help build a state that can be a national leader for decades to come."

Minnesotans Cast Record Number of Ballots

Minnesota Secretary of

State Ritchie announced on November 7 that

Minnesotans cast a record number of ballots in yesterday's election. With 99.93 percent of precincts reporting 2,938,947 voters cast ballots in the presidential race. Since most voters cast votes in the presidential race, this number is a good indicator of voter turnout while counties are proofing their data entry and entering statistics about the total number of actual voters. By comparison 2,921,147 voters cast ballots in the 2008

"The voter turnout number will increase as the final precincts report their results," said Secretary of State Ritchie.

presidential election.

This record number of voters is about 76 percent of Minnesota's estimated eligible voters. The number of



estimated eligible voters has increased by 135,238 voters since 2008.

According to the Christian Science Monitor Minnesota has had the highest voter turnout in 12 of the past 16 elections, including the past eight straight. Minnesota's average eligible voter turnout in the past six elections – 67.6 percent – is 16.4 percentage points higher than the national average.

The Minnesota AFL-CIO is a labor federation made up of more than 1,000 affiliate unions, representing more than 300,000 working people throughout the state.
