

## **Health & Benefit Fair Saves Lives in Numerous Ways**

"The free massage was very good," says Terry. Ron joined BAC in 1979 and retired three years ago. The couple live in the Royalton, MN area, 100 miles northwest of Minneapolis.

The 2014 Health & Benefit Fair held on April 26 at the Minneapolis Convention Center mirrored last year's event in participant numbers. The fair is a collaborative effort between the Labor/Management Health Care Coalition of the Upper Midwest and 20 member funds.

It is the largest in the country. Labor health fund members and their families had the opportunity to participate in family centered activities, education and information focused on the improvement of health and lifestyle. Attendees spoke with representatives from more than 80 health-related businesses. Children took advantage of a play area and climbing wall. Minnesota Senator Al Franken also spoke briefly offering his support for the Unions and the current health care issues they are facing.

More than \$10,000 worth of prizes were given away. Of the 90 participants who received a free screenings by St. Paul Radiology, 12 will require additional medical follow up. Memorial Blood Centers sends out a heartfelt thank you to all who donated blood. The 39 units collected will save up to 117 lives. The response was greater than anticipated. The event was free to all attendees and funds. Next year's event is scheduled for May 2 at the same location.

discovering that "A shovel fit my hand better than a pencil" he says, taking college out of the equation. In 1976 he began his nearly four-decade career with BAC Local 1 MN/ND. Since then he's worked as a brick and blocklayer, stone, marble and cement mason, and later an apprentice instructor. In 2000 he began serving the members he worked alongside with as a business representative.

Kentzelman enjoyed bouncing from job to job. "They were all good," he says. As a business rep he appreciated the opportunity to take care of the members and resolve their issues. He also enjoyed working with the younger people and watching them grow within the industry. Kentzelman's advice to them and others is that it will be tough at times, but stay with it. "The end result is you can retire with dignity, with health insurance and a decent union pension," he says. "It is worth the time and effort."

The Maple Grove, MN, resident and his wife, Mandy, have two adult children. Although he has no plans for retirement, Kentzelman confidently states, "I'm going to start my second childhood and try to guarantee myself 40 good years." No doubt his involvement with his church, Lions Club, hunting and fishing, and volunteering with Building Trades and the AFL-CIO will keep him busy.

The Monday following the health fair, Kentzelman's plans were to go to the gym at 5 a.m., like he has for the past several years. He works out five days a week. "That's how I start my day," he says. "It sets the tone for the day."

It's a healthy way to begin those 40 years, too.

Dick Kentzelman resigned as Vice President on April 30. Doug Schroeder was appointed to fill the remainder of the term until the next election.

## Important Changes Regarding Your HRA Account

Beginning May 1, 2014, employer contributions to the Minnesota and North Dakota Bricklayers & Allied Craftworkers HRA resumed, however there are some notable changes to the Plan in order to comply with new provisions of the Patient Protection and Affordable Care Act (PPACA).

If you are a retiree there will be no change for you other than the use of the new request for reimbursement form that was mailed out in May.

If you are an active member enrolled in qualified coverage either through the Fund or provided by your employer or your spouse's employer, there will be no change for you. Your coverage in the HRA will continue in the same manner, and you will be able to receive reimbursement for the same medical expenses as in the past. After May 1, 2014, all active participants will be required to attest on the new reimbursement form that they are enrolled in coverage either through the Fund or a qualified employer sponsored group health plan that provides minimum value at the time the claim was incurred.

If you are either uninsured or you purchased your own coverage from an insurer or the Health Insurance Marketplace, there will be a change in the expenses that are eligible for reimbursement. Reimbursement will be limited to certain non-essential or "excepted benefits." Additional coverage information can be obtained from the Fund Office.

PPACA also requires that the HRA must allow members to opt out of the Plan at any time. This opt out provision is for members that would like to seek Exchange based coverage and take advantage of any available subsidies. Participation in this HRA Plan may prevent you from being eligible for coverage in the Exchange. Members who choose to opt out may re-enroll at a later date if they so choose. Additional information and forms can be obtained from the Fund Office.

#### **HRA Benefit Enhancement**

The Fund is also working on a project to make more money available to members in their HRA accounts. On Jan. 1, 2014, the Health Fund moved from a Quarterly Hour Bank Eligibility System to a Monthly Dollar Bank System. Currently balances in the Dollar Bank can only be used for premiums to grant eligibility under the Health Fund. In the near future, a program will be implemented that will keep three months of premium at the selected level of coverage in the Dollar Bank, and roll the balance into the HRA for members to use for qualified health expenses. Watch your mail for an announcement regarding when this benefit enhancement will take effect.

## **From the President**

#### **Negotiations**

We have come to agreements with the employers with all of the BAC Local 1 MN/ND contracts that expired on April 30, 2014. The new wages and new contract terms for each area and craft are included in this article.

Work hours for 2013 were up 4 percent over 2012. 2012 hours were up 8.04 percent from 2011. We are definitely heading in the right direction. The hours during the first four reporting months of 2014 are up 23.16 percent. All outlook indications show us that there is more work out there and that work hours will continue to increase. Do you know someone who would like to work as a bricklayer, tile layer, caulker, tile finisher, precast mason, marble mason, cleaner or restoration worker? Please call us at the local union to let us know. Many of our signatory employers are looking for more help. I would also like to remind all of our current members to make sure that you welcome all the new employees that you see on the job. Ask for their card. If they are not members, give us a call. We will get out there and sign them up. If you don't feel comfortable with the confrontation, just call us and one of the business representatives will stop out to sign up the new member and get them enrolled as soon as possible into the benefit programs.

The following are the settlements that we have reached:

Northwest Minnesota Area Bricklayers and Cement Masons. We agreed to a two-year contract with wage increases of \$1.35 on May 1, 2014, and \$1.65 on May 1, 2015. The new two-year contract will expire on April 30, 2016. This contract covers 27 counties in Northwest Minnesota. We settled on a two year contract to get back

on the same cycle as the rest of the bricklayer contracts in Minnesota.

**CMU Insulators** agreed on a one-year contract with a wage increase of \$.85 on May 1, 2014.

**Eastern North Dakota.** This contract is split into two wage areas.

- The **Fargo area** bricklayers, blocklayers, PCC's agreed to a three-year contract with wage increases of \$1.35 on May 1, 2014, \$1.65 on May 1, 2015, and \$2.00 on May 1, 2016. This contract covers nine counties in Southeast North Dakota.
- The **Grand Forks** area bricklayers, blocklayers, PCC's, cement masons and plasterers agreed to a three-year contract with wage increases of \$1.25 on May 1, 2014, \$1.25 on May 1, 2015, and \$1.25 on May 1, 2016. This contract covers 14 counties in Northeast North Dakota.
- The total wage package for Grand Forks will be \$.65 more than Fargo on May 1, 2014. It will be \$.25 more on May 1, 2015, and Grand Forks will be \$.50 less than the Fargo total wage package on May 1, 2016.

Western North Dakota. This contract is also split into two wage areas.

- The **Bismarck** area bricklayers, blocklayers, and PCC's agreed to a three-year contract. Wages will freeze from May 1 through June 30, 2014, with wage increases of \$1.25 on July 1, 2014, \$2.25 on May 1, 2015, and \$1.75 on May 1, 2016. This contract covers 18 counties in Southwest North Dakota.
- The **Minot** area bricklayers, blocklayers, and PCC's also agreed to a three-year contract. Wages will freeze from May 1 through June 30, 2014, with wage increases of \$1.25 on July 1, 2014, \$2.25 on May 1, 2015, and \$1.75 on May 1, 2016. This contract covers 12 counties in Northwest North Dakota.
- The total wage package for Bismarck and Minot will be the same throughout the new contract.

Username and Password or create one by clicking "Forgot your Username or Password". Under Details and Documents select the MN & ND Bricklayers and Allied Craftworkers HRA Account and select the Link to view HRA Accounts and Balances. Once you access your account, you will be able to view your HRA account balance and HRA claims activity. # Officer Qualifications ARTICLE VIII

- 1. The elected officers of this Local Union shall consist of a President/Secretary Treasurer, an Executive Vice President, and three (3) Vice Presidents. In addition, the members of each chapter shall elect the following chapter officers: chair, recording secretary, and sergeant-at-arms.
- 2. The elected officers shall be elected for a term of three (3) years commencing on the first (1st) day of the calendar month following the month in which the election is held.
- 3. No member shall be a candidate for or hold more than one (1) elected office at the same time.

#### 4. Qualifications for Office

- A. In order to qualify as a candidate for any elected office in this Local Union a member shall be required:
  - (1) to have been a journeyperson member continuously in this Local Union and in the International Union for a period of two (2) years immediately prior to nominations; and
  - (2) to be current in the payment of his/her dues; provided that the President/Secretary Treasurer shall accept payment of any dues in arrears at the nomination meeting prior to the opening of nominations.
- B. No person who has been debarred by the International Union or any Local Union after trial from holding office shall be qualified as a candidate or hold office during the period of his/her debarment.
- C. A contractor member, or a supervisory member who works in a supervisory position on a continuous and ongoing rather than project by project basis, with the effective authority to hire, fire or impose substantial discipline, may not be a candidate for or hold office.
- D. Retired and disabled members who are collecting Local Union pension or IU pension benefits may not be a candidate for or hold union office unless they cease being a retired or disabled member for a period of twelve (12) months prior to the date of nominations.

# Bricklayers & Allied Craftworkers Local 1 MN/ND Mutual Relief Association

This is a summary of the annual report for the Bricklayers and Allied Craftworkers Local 1 Minnesota/North Dakota Mutual Relief Association (Employer Identification No. 41-0164670 Plan No. 501) for the period January 1, 2013 to December 31, 2013. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$306,206 as of December 31, 2013, compared to \$344,393 as of January 1, 2013. During the plan year the plan experienced a decrease in its net assets of \$38,187. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$5,140, including income from investments of \$5,140. Plan expenses were \$43,327. These expenses included \$32,000 in benefits paid and \$11,327 in other expenses.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- 1. An accountant's report;
- 2. Financial information and information on payments to service providers;
- 3. Assets held for investment;
- 4. Transactions in excess of 5 percent of the plan assets.



## University of Minnesota Students Team with BAC Training for Build and Design Project

Structural masonry, large format tile classes and masonry workshops with the University of Minnesota were front and center on the IMI agenda this spring. IMI Director Mark Swanson reports strong showings in all of these areas which are key to providing a continuing source of work for BAC members and contractors.

#### **Structural Masonry**

Sixty structural architects and engineers attended the Structural Masonry Day on March 12, 2014, hosted by the Minnesota Masonry Coalition (MMC) at International

Market Square in Minneapolis, along with field coordinators from Ryan Companies and owners such as University of Minnesota and Dairy Queen. Swanson as well as structural engineers Sam Rubenzer and Scott Walkowicz delivered seminars on structural masonry case studies, structural software solutions and grouting and reinforcement.

IMI, BAC and MMC also sponsored a presentation by Sam Rubenzer at the Minnesota Structural Engineering Association in April. Many of the top engineering firms attended the seminar on structural masonry shear wall design, including OPUS, Mattson McDonald, BKBM and AMEC.

training session on large format tile at the Cotton Training Center hosted by BAC Business Representative Stan Paczynski. BAC TMT Craft Director Mike Hawthorne was also in attendance. Swanson and Martagon pointed out that working with large format tile and stone requires a greater expertise in handling these materials as well as understanding the tighter tolerances required in the substrate. In the past, a 12" x12" was considered large but now some of the new thin tiles are 10' x 3', which can present installation challenges such as lippage, bonding and cracking if installers are not

properly trained. Kate-Lo Tile & Stone and Laticrete provided a classroom session along with a hands-on training to the group from Contract Tile.

#### University of Minnesota Masonry Workshop

IMI worked along with the architectural students from the University of Minnesota to wrap up their final design projects in March at the BAC/IMI Training Center in St. Paul. Swanson along with instructor Dave Mensing provided the students with a hands-on experience where they created a masonry design and then built a mockup panel. "I can tell you that as an architect myself, these types of programs where students get to interact with skilled craftworkers as well as our masonry materials really gets them

excited about designing with masonry," says Swanson. Local masonry suppliers donated materials and Local 1 Business Agent Doug Schroeder was one of the judges grading the final designs.



## Legislators Accomplish Much for Working People

The Minnesota Legislature gaveled to an early end on May 16, capping off one of the most productive two years in recent history. Much like the 2013 session, 2014 saw major gains for working Minnesotans.

The session's results are great news, especially for workers in the construction industry. Lawmakers sent Governor Dayton legislation authorizing more than \$1 billion in construction projects that will put more than 30,000 people to work in upgrading and expanding our state's infrastructure. Lawmakers also sent the Governor responsible contracting legislation. The law establishes a set of criteria to ensure that only responsible and safe contractors are given state construction jobs.

Union workers certainly have a lot to be happy about this session, and so do Minnesota's low wage workers. Starting in August, Minnesota's minimum wage will begin to increase every year until it reaches \$9.50 per hour in 2016. Starting in January of 2018, the minimum wage will increase every year to keep up with the cost of living. The Labor-led effort to raise the minimum wage was a great opportunity for us to work with non-profit, faith, and community groups on something that benefits all workers.

Other important accomplishments over the last two years include:

- The Women's Economic Security Act
- Safe & Supportive Minnesota Schools Act
- The first wage increase for nursing home workers in 4 years
- Five percent increase in rates to community-based services for people with disabilities and older adults
- Health Insurance Transparency & Accountability bill, increasing competition in school employee health care
- A 26-week extension of unemployment benefits for any worker whose employer locks them out
- Agreement between Labor and business on workers compensation reform that increases benefits to injured workers and finally recognizes psychological trauma as a workplace injury
- The right for childcare providers

- and personal care attendants to vote on whether they want to form a union
- Balancing the budget with adequate revenue and without shifts and gimmicks

Elections matter. Working people did well at the Capitol in the last two years, because Labor-endorsed candidates were elected to office. The next election is less than six months away. If we want to build a better Minnesota, it's important that we re-elect Labor-endorsed candidates like Governor Mark Dayton and Senator Al Franken and make sure we send a pro-Labor majority back to the Minnesota House. If we work hard, I know we can win in November.
