Union Members Set Minnesota Milestone with Arriscraft®

In September 2010 a ground breaking ceremony was held for the new Mayo Clinic Radiation Oncology Treatment Facility in Northfield, Minn.

In February of this year the facility began taking shape thanks in part to BAC Local 1 MN/ND Union members. The facility will be the first of its kind in the state of Minnesota to feature an exterior made of primarily Arriscraft® Building Stone, nearly 6,000 sq. feet of it.

This unique calcium silicate product is manufactured with a Natural Process technology and echoes natural stone formation. And although it looks like and performs similar to quarried stone it has many advantages over its heavier counterpart. For more detailed information read the article Arriscraft Thin-Stone Solutions found in this issue.

Rob Frahm, mason and foreman for Twin City Tile and Marble, attests to the fact that his masons on the job site are experiencing a "definite learning curve" as is expected when working with any new product. "If you've never seen the product before, it takes time to learn. It's a pretty decent product, though, once you've learn the ins and outs."

Mason Frank Fundingsland stresses how labor intensive first time installation can be. "There are so many factors involved; having straight walls to dropping in shims where needed and insuring that the brackets or channels line up perfectly so you can install the stone."

Joe Becker, vice president of the stone division and project manager for Twin City Tile and Marble, is confident that his guys can pull it off. "Frahm is a hard worker and has strong masonry experience. It's a simple system with a fast learning curve so it's a matter of sticking with it and thinking ahead," he says.

In spite of the initial tweaks and adjustments, Frahm is also confident that as they get further in the project it will move more smoothly. In fact, Arriscraft approached the masons because the company believes they are the ideal work group to install the product. They are skilled and experienced in knowing what the finished product should look like.

"It's another type of exterior masonry installation that will be more prevalent in our community with the green movement," says Becker.

Not only are BAC Union members securing their future by moving ahead to stay in step with current technological changes within the building industry, with the construction of the Mayo facility, they will be the first to do so in Minnesota in a big way.

It will take about six weeks to complete installation of the Arriscraft Building Stone.

Twin City Tile and Marble will also be installing approximately 600 sq. ft. of interior natural stone from Winona and Mankato, Minn.

"Right to Work" is a Rip-Off

You might have heard the media hype about the so-called "right to work" law that the Minnesota Legislature is currently considering. It is important to set the record straight. This is particularly true for Union members since much of what we have worked so hard to build over all these years is at risk.

So what does "right to work" mean for you? What it really means is the right for anti-union employees to freeload at our expense. Anti-union employees could work under our union contracts and take advantage of our higher wages and benefits without paying a dime in return. The costs for the union to represent and refer out these anti-union employees would have to be picked up by you and your fellow union members. They get the referrals and representation, they get the work for nothing, and you pick up the tab. This is why "right to work" is a rip-off.

Why are the anti-union forces pushing for this legislation? They see it as a way to divide and conquer the unionized workforce. If they can encourage people to freeload, they can pit brother against brother and they can undermine our finances and our bargaining power. We need to make our voices heard to stop this attack on our traditions and our strength. Please make your voices heard to your political leaders, to your friends and family, to your fellow union members, and to the public.

Because you care about your job and the future of your Union, contact your Minnesota Senators and Representatives, whether Republican, Democrat, or Independent, and make your voices heard that "right to work" is a rip-off.

Local Union Vacation Fund

Dues will be taken out of the Local Union Vacation Fund for February 2011 through January 2012 for those members signed up on this program. Please send in your IU membership cards to be stamped up-to-date after you receive your receipt. Those bricklayer members living or working in the Duluth area can have their dues taken out of the Hermantown Credit Union on a quarterly basis. If you did not work during 2010 you must send in a check to keep your dues current.

Negotiations Update

There is some unfinished business left from 2010 regarding negotiations. The Ceramic Tile contract was combined so that one contract covers the states of Minnesota and North Dakota. This includes both Tile Layers and Tile Finishers. However, the wages have not been finalized for western Minnesota, North Dakota and the Duluth area. We have continued to work in these areas under the terms of the old contract. We also continue to meet and hope to finalize the wages for these areas soon.

We are now in Federal Mediation trying to settle the Terrazzo contract. We are continuing to work under the terms of the old contract just like we have with the Ceramic Tile. We hope to finalize this contract soon.

The Marble Shop Workers and the Material Handlers also continue to work under their old contracts. We have discussed this contract with the employer and should complete the contract soon.

What's Up in 2011

The CMU Insulation Contractors signed a one year agreement in 2010 which covers both Minnesota and North Dakota. This contract will be open in 2011 and we hope to get a multiyear contract that will get us back on the same contract cycle as the Masonry contractors in Minnesota.

The Masonry contracts for the entire state of North Dakota will expire in 2011. The Eastern contract covers the main cities of Fargo and Grand Forks. The Western area contract covers the main cities of Bismarck and Minot. Contract talks will start soon in these areas.

The Masonry contract in Northwest Minnesota also expires this spring. We will be sitting down with the contractors in this area to begin negotiations soon.

We will post results on our Web site at bac1mn-nd.org as negotiations proceed and as contracts are completed with all of these areas and crafts.




Arriscraft Thin-Stone Solutions

Arriscraft International has been around since the late 1940's and has been known during that entire time as a 4" full-bed stone masonry veneer manufacturer. As the company grew and evolved we realized that there were other systems and methods for installing stone on walls and we started looking at new ways to help increase the wall share of our stone masonry products. This led to the development of our ARRIS tile and ARRIS clip Thin-Clad Renaissance® Units. The intent of this article is specifically to focus on the benefits of the ARRIS*clip product line.

ARRIS^aclip originated from some lessons learned working with materials such as metal panel, terracotta rainscreen, glass and metal curtain wall. ARRIS clip is a 1-3/8" thick Calcium Silicate Stone Unit that is hung or suspended from a suitable substrate on a family of extruded aluminum channels.

While full-bed masonry remains the corner stone (pun intended) of Arriscraft Internationals product offering there are many times where an alternative solution to fullbed masonry makes more sense and a lighter curtain wall solution is more effective. ARRIS clip still remains in the masonry section since the stone is still part of the system and it takes a mason to truly make the stone "sing" in the wall; the only difference is how the stone is installed.



University of Akron

Some examples to prove our point would be the University of Akron in Wayne. This project included a 20' cantilever off the end of the building where to suspend full-bed masonry would have been a significant engineering feat. Using a lighter system that could be suspended from the substrate had significant advantages and instead of having to use metal panel to try to save weight this allowed the architects to use stone cost effectively.

Another example is the University of Toledo's Snyder Hall in Columbus, OH, which was slated for demolition. Since a re-use application would require the re-use of the existing structure a light weight stone solution was required so it would tie into the existing buildings and re-use the existing structure. Many options were considered and in the end it looked like tearing the building down and constructing a new one was the only option that would work. That was until ARRIS clip was suggested as an alternative. The project team saw the possibilities in the system and decided to move forward with re-cladding the building in a tight eight month design and construction schedule.

The Virtua Healthcare Facility in Washington Township, NJ, was always going to be a curtain wall type of



installation and ideally stone. One of the design ideas was to create the appearance of stone "floating" over glass. Natural stone hung off the wall was going to be too expensive and full-bed added significant structure which presented its own challenges. ARRIS*clip was the perfect solution since it created the lighter walls. The system being used to create the soffit installation created the appearance of stone "floating" over glass.

Other interesting concepts for ARRIS clip material include barrel vaults, high rise ARRIS clip installations like the 32-story Mirabella Assisted Living Condos in Portland, OR, and open rainscreen installations like the Virtua Hospital in Voorhees, NJ, and soldier course stack bond applications.

Masons installed all of the highlighted projects and as noted above the material is specified in Division 4 due to the stone component. In the end ARRIS clip opens up the possibilities for using stone in the wall for designers and this creates opportunities for not only us as a company but also the masons across the country.

INTERNATIONAL MASONRY INSTITUTE



"Hanging on to the old while embracing the new."

On January 3 of this year, IMI offered the first training session that specifically dealt with AAC or (Autoclaved Aerated Concrete). The session went well and was for the most part accepted by those present. The result at the end of the day was that BAC Local 1 MN/ND registered its first 18 certified AAC installers and three more of our Signatory Contractors were exposed to the qualities and characteristics of AAC.

Mixed audiences can be interesting. I later heard from one of the Contractors in attendance state the following; "AAC is really a fascinating and interesting material, but it seems that it may have trouble gaining a foothold because some of your journeymen don't seem to like installing the product." I found the comment very interesting and very disturbing at the same time.

If there are new materials and new systems laid at our feet, we should be picking them up to learn more about them. We should be curious about the new work opportunities, and attempt to learn which steps we will need to take in order to gain the strongest market position. To exercise resistance or indifference to these new materials will not get us too far.

Resistance to a new idea or technique is normal. Our trade has always been challenged with holding on to our traditions all the while facing headlong into the winds of change. Change and innovation are constant and often don't warn you exactly when the next opportunity is coming. If we are faced with inevitable changes to methods used to build masonry in the future, I will do everything I can to encourage our members to prepare themselves so that they may take the greatest advantage of these new developments.

On Tuesday March 29, 2011, there will be yet another opportunity to attend multiple presentations on new materials and systems. At the time of this publication, arrangements are being made to offer a full day of presentations in coordination with the following distributors:

 Arriscraft thin cladding system – A factory representative will be giving a lecture about the Arriscraft thin cladding products. A factory installer will also be present to exhibit the actual installation process. Arriscraft will also be highlighting other samples from their Ashlar pattern product line.

- Vapor Barrier Sprayed Products A representative from EBS (Exterior Building Services), will be giving a lecture on substrates and the application of various spray membranes to those substrates. Hopefully, there will also be a hands-on presentation from this vendor as well.

Three Steps to a Better Minnesota

Another legislative session is upon us, but the players and playbook have changed. With Mark Dayton in office, Minnesota has a labor-friendly Governor for the first time in more than two decades. At the same time, Republicans are in control of both legislative chambers for the first time in 30 years.

While the playing field has changed, Minnesota's problems haven't. More than 200,000 Minnesotans are still out of work. These are people who want and need a job to provide for their families. At the same time, the state is also facing a multi-billion dollar budget shortfall. All the budgeting gimmicks, IOUs, and shifts to local property taxes have been exhausted. Eight years of relying on cuts alone has not solved the problem.

However, while we face these challenges, there is also an opportunity to build a better Minnesota for everyone. That's why the Minnesota AFL-CIO recently

proposed our "Three Steps to a Better Minnesota" legislative agenda.

Step 1: Create Family Sustaining Jobs Now

While Minnesota is better off overall than many areas of the country in our overall unemployment rate, our construction sector is lagging behind with nearly 20 percent of workers in the building trades unable to find work. State Economist Tom Stinson said construction workers have taken the hardest hit out of everybody in this recession.

A billion dollar jobs and infrastructure bill targeting shovel-ready projects, for example, would quickly put 28,000 Minnesotans back to work in private sector jobs.


Step 2: Balance the Budget Fairly

With a \$6 billion dollar revenue shortfall, everyone agrees there are no longer easy solutions to the state budget.

If we want our kids to attend the best public schools in the nation, have a highly-skilled workforce that attracts business, efficient public services, and safe infrastructure; we cannot continue this current course.

That's why the Minnesota AFL-CIO is advocating for fairly-raised revenue as part of a budget solution.

The richest Minnesotans pay less than 9 percent of their household income in state and local taxes while the average working family pays more than 12 per-



cent. To balance this budget without further damaging Minnesota's economy and hurting every Minnesotan's quality of life, there must be new revenue, and it must come from those who have benefitted most, the rich.

Step 3: Stay Focused

With so many people out of work and a budget crisis of this magnitude; the Minnesota AFL-CIO is urging our leaders to stay focused on what Minnesotans elected them to do.

Now is not the time to bring up divisive social issues or score political points for the next election. It's time to do what is best for Minnesotans. It is time to focus on job retention and creation and fairly balancing the budget.
